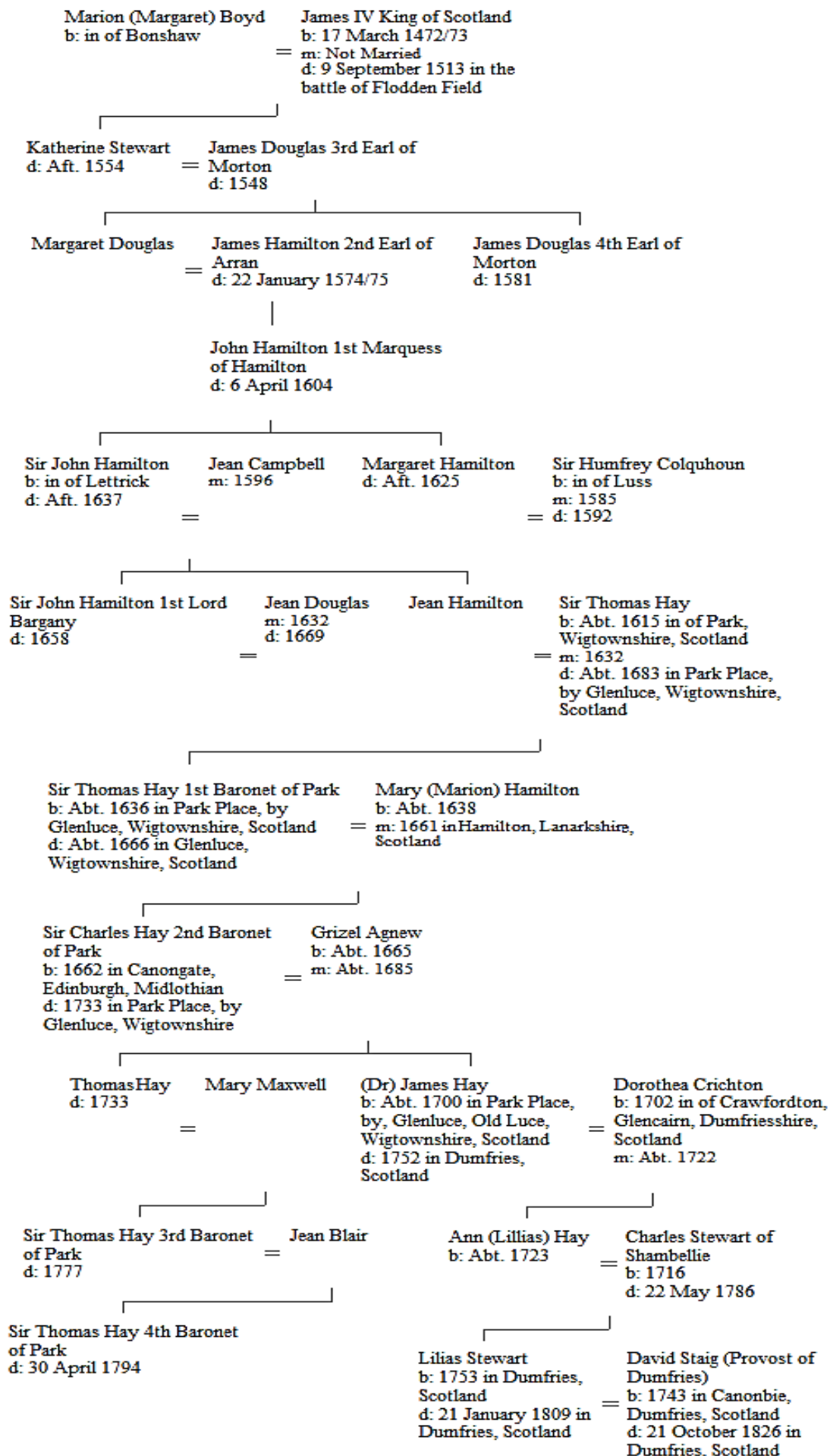


## Descent of Liliastewart of Shambellie from James IV, King of Scotland

Note: *Complete Baronetage, G.E. Cokayne (Editor of The Complete Peerage), Volume III, 1649-1664*, Exeter, William Pollard & Co. Ltd. 1903 incorrectly gives the 1<sup>st</sup> Baronet of Park's mother as Margaret

Kennedy. Whilst the 1<sup>st</sup> Baronet was married to a Margaret Kennedy, he had no children by her and the 1<sup>st</sup> Baronet's mother was Jean Hamilton to whom the 1<sup>st</sup> Baronet's father was also married to. This was confirmed in a letter written by Sir John Hay, 11th Baronet of Park, dated 21 August 2001, and directed to the Family History Library of the Church of Jesus Christ of Latter Day Saints (the largest repository of genealogical records in the world).

McCulloch, Matador, 2015 also states {on page 64} that her name was Ann. Her eldest daughter was also named Ann, while her 3<sup>rd</sup> daughter was named Lilias).
