Sir Fulque Melville Gerald Noel Agnew, 10th Bart., *b.* 6 Oct. 1900; educated at Harrow; lieut. 4th batt. Royal Sussex Regt. (T.A.); *s.* his uncle 1928.

Sir Andrew Agnew was a grandson (through his mother, Anne [or Agnes] Stewart) of Sir Alexander Stewart, 1st Earl Of Galloway (d.1649).

Sir Alexander Stewart was created 1st Lord of Garlies [in the peerage of Scotland] on 19 July 1607. He was created 1st Earl of Galloway [in the peerage of Scotland] on 19 September 1623, with a special remainder to his heirs male bearing the name Stewart. He was also invested as a Privy Counsellor (P.C.).

He was an 8 greats grandfather of Sir Winston Spencer Churchill (1874-1965) through the marriage of the 8th Earl of Galloway's daughter (Jane Stewart, 1798-1844) to George Spencer-Churchill, 6th Duke of Marlborough (1793-1857).

The Agnews of Lochnaw were descended from Robert III, King of Scotland through Margaret Kennedy of Culzean, wife of the 1st Baronet of Lochnaw, Sir Patrick Agnew (d.1661). Margaret Kennedy was a daughter of Sir Thomas Kennedy of Culzean (d. 1602), son of Gilbert Kennedy, 3rd Earl of Cassillis (1515-58). The Earls of Cassillis were descended from Robert III's daughter, Princess Mary Stewart's marriage to Sir James Kennedy of Dunure in 1405.

David Staig was the Provost of Dumfries for many years between 1783-1817, he was also a banker (he was the agent for the Bank of Scotland in Dumfries) and was a Deputy-Lieutenant of the county of Dumfriesshire.

Extract from - History of the Burgh of Dumfries - Chapter XLVIII:

At Michaelmas, 1783, a gentleman was elevated to the provostship, who, for more than a generation

afterwards, took a leading part in public affairs - Mr. David Staig.

If, during much of that time, any one deserved to be termed the king of the town, it was he. It is related of a member of Council, who, being rather deaf, could not well hear the discussions, that he habitually asked, before a vote came to be taken, "What does Provost Staig say? I say the same as Provost Staig." And to many councillors besides this openly subservient one, Mr. Staig's word was law.

He had a fair share of natural abilities; was shrewd, inventive, enterprising, politic, fond of power, not insensible to flattery; was, withal, warm-hearted and virtuous - using his influence, so far as his judgment went, for the advancement of the public weal. For upwards of forty years he represented the Bank of Scotland in the Burgh - and was thus a monetary potentate, with a host of most obedient subjects; and but for the electoral law, that prohibited one man from being chief magistrate longer than one year, or two at most together, under a penalty of a thousand pounds Scots, he might have reigned as provost for life.

The genealogical tree of the family, in possession of William Stewart, Esq. of Shambelly, exhibits its connexion with Robert the Bruce, in a direct line.

In addition to family honours of such a rank, Colonel Stewart acquired others of no common extent, personal to himself. During about thirty years of active military service in America, Holland, Spain and Egypt, under Sir Ralph Abercrombie, Lord Moira, and General Sir John Moore, he was present at the battles of Brandywine and Monmouth, the taking of Philadelphia, the siege of Charlestown, the reduction of St. Lucia, the storming of St.

Vincent's, the attempt on Cadiz, the reduction of Minorca, the action at Aboukir, March 8, 1800, the surrender of Cairo, the siege of Alexandria, and numerous smaller actions; and was repeatedly severely wounded.

David Staig became a partner in John Anderson & Co., Bankers (Fermoy). John Anderson (1747-1820) and his son, Sir James Caleb Anderson (Baronet) 1792-1861 were the other partners in this company. The bank failed in 1816 and John Anderson, his son Sir James Anderson and David Staig were all (apparently) bankrupted as a

result of the failure.

John Anderson had been offered a Baronetcy for his services to the town of Fermoy, however he graciously declined and the Baronetcy was then offered (in 1813) to his son, James Caleb Anderson.

John Anderson was from Portland near Dumfries (and we can only assume, was more than likely to have known Provost David Staig in the latter's capacity as the agent for the Bank of Scotland in Dumfries) and this probably explains how David Staig (the younger) ended up in Fermoy, Ireland.

At some point (probably in the 1850s and certainly prior to 1855), David Staig and his three daughters (Marianne, Catherine and Liliias) moved from Fermoy to Clonmel.

Notes for Catherine Peard:

The Peards of Coole Abbey were Anglo-Irish landed gentry. Their forebear, Richard Peard (1595-1683) had come to Ireland from Devon, England (parish of Welcombe) *circa* 1641.

He was also concerned with successful operations against Chinese pirates in the 1840s. He commanded HMS Victory from 1854 and then commanded HMS Hannibal during the Crimean War and was decorated by the British and Turkish governments. He was promoted to captain in 1850 and commanded HMS Indus from 1856. He was promoted to rear admiral in 1866, before retiring as an admiral in March 1878. He was Fourth Naval Lord from 1866 to 1868.

Dalrymple-Hay was a Conservative politician. He served as Member of Parliament (MP) for Wakefield 1862-1865. He lost an election at Tiverton on 28 February 1866. He represented Stamford 1866-1880. In 1880-1885 Admiral Hay was the MP for Wigtown Burghs.

Dalrymple-Hay married the Hon. Eliza, daughter of William John Napier, 9th Lord Napier of Merchistoun in 1847. They had three sons and six daughters. Lady Dalrymple-Hay died in 1901. Dalrymple-Hay survived her by eleven years and died in January 1912, aged 90. He was succeeded in the baronetcy by his second but eldest surviving son, William.
